

THE CORPORATION OF THE COUNTY OF PRINCE EDWARD

BY-LAW NO. 1897 -2007

BEING A BY-LAW TO AMEND BY-LAW 421-2000 BEING A BY-LAW TO PROVIDE FOR THE MAINTENANCE, MANAGEMENT AND CONTROL OF ALL MUNICIPAL CEMETERIES IN THE COUNTY OF PRINCE EDWARD IN ACCORDANCE WITH THE CEMETERIES ACT.

WHEREAS the Corporation of the County of Prince Edward, by By-law 421-2000 established the Prince Edward County Cemetery Board; and

WHEREAS By-law 421-2000 was approved and filed by the Ministry of Consumer and Commercial Relations, Cemeteries Regulation on February 21, 2000 in accordance with the regulations under the Cemeteries Act ; and

WHEREAS By-law 421-2000, Section B Administration, No.1. prescribes the maximum number of members to be appointed to the Prince Edward County Cemetery Board; and

WHEREAS the Council for the Corporation of the County of Prince Edward deems it necessary to increase the size of the Prince Edward County Cemetery Board from a maximum of 9 members to a maximum of 12 members; and

WHEREAS By-law 421-2000, Section F Interment, No. 5 specifies which cemeteries allow burials in the winter months; and

WHEREAS the Council for the Corporation of the County of Prince Edward deems it necessary to amend Section F Interment, No. 5 to exclude winter burials in the Sophiasburgh Cemetery; and

WHEREAS the Council of the Corporation of the County of Prince Edward deems it necessary to replace Schedule 'A' of By-law 421-2000 as amended, to accurately reflect the Cemeteries that are now under the management and control of the Corporation of the County of Prince Edward; and

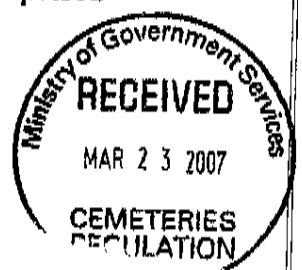
WHEREAS the Council of the Corporation of the County of Prince Edward deems it necessary to amend Schedule 'B' of By-law 421-2000 as amended, to reflect the decrease in G.S.T. charged.

NOW THEREFORE the Council of the Corporation of the County of Prince Edward enacts as follows;

1. **THAT** Section 'B' Administration, No.1. of By-law 421-2000 be deleted in its entirety and replaced with the following new clause 1;

"1. The business and affairs of the cemeteries which are the responsibility of the Corporation of the County of Prince Edward shall be managed and supervised by a Board composed of a maximum of 12 members, comprised as follows:

- 1 Council Member from Recreation, Parks and Culture Committee
- 1 Council Member at large
- 1 Representative from Glenwood Cemetery Board
- 1 Representative from Wellington Cemetery Board
- 1 Representative from Salem Cemetery Board
- 7 Members of the public"

2. THAT Section 'F' Interment, No. 5 of By-law 421-2000 as amended to read as follows:

"Interments may take place year round in the active cemeteries located in Ward 2 (Bloomfield. Interments in the Ward 8 (North Marysburgh) Rose Cemetery and Ward 10 (Sophiasburgh) Sophiasburgh Cemetery shall be between the 15th of April and the 15th of December. All interments are at the approval of the Cemetery Manager".

3. THAT Schedule 'A' attached to By-law 421-2000, as amended is hereby repealed and replaced with a new Schedule 'A' attached to this By-law.

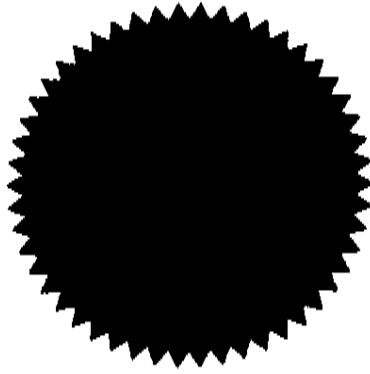
4. THAT Schedule 'B' attached to By-law 421-2000, as amended is hereby Repealed and replaced with a new Schedule 'B' attached to this By-law.

5. THAT the provisions of this by-law shall come into force and effect on the date that it is filed with and approved by the Registrar.

A surcharge of \$100.00 plus G.S.T. will be charged for opening/closing of cremation plots on Saturdays, Sundays and statutory holidays.

Fees for opening/Closing may vary according to site.
